Scripture Text: Romans 13:11, Isaiah 60:1, Acts 1:8 and Revelation 22:12

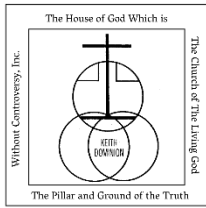
It is my desire that each of you will continue to fast and pray for the success of this annual meeting.

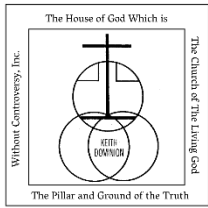
As done in previous years, large churches are asked to contribute \$500.00 for State Assembly operational expenses, and small churches are asked to contribute \$250.00.

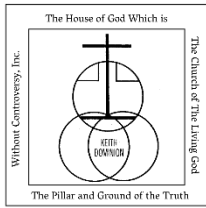
